# **OUR APPROACH**

FREE THE SLAVES knows that slavery flourishes when people cannot meet their basic needs. Slavery is rampant when poor people lack economic opportunities, education, healthcare and honest government. A holistic approach is required to eradicate slavery forever. That is why we:

- Free slaves around the world by working with grassroots organizations.
- Record and share their stories so people in power can see slavery first-hand and be inspired to work for freedom.
- Enlist businesses to clean slavery out of their product chains and empower consumers to stop buying into slavery.
- · Work with governments to produce effective anti-slavery laws then hold them to their commitments.
- Research what works and what doesn't so that we use resources strategically and effectively to end slavery. Forever.

# WHAT WE KNOW ABOUT SLAVERY

- · A slave is someone who is forced to work without pay, under threat of violence, and cannot walk away.
- There are 27 million slaves in the world today.
- Thousands of slaves are trafficked into the United States each year. Thousands more U.S. citizens
  are trafficked within our borders.
- The majority of slaves can be found in India and in African countries.
- \$90 is the average cost to buy a human slave around the world.
- \$370 is the average cost to free a slave

FREE THE SLAVES liberates slaves around the world and attack the systems that allow slavery to exist.

# **WORK WITH CONSUMERS**

**FREE THE SLAVES** helped gather public support for the passing of two key pieces of anti-slavery legislation: the California Supply Chain Transparency Act and the Conflict Minerals Act.

**FREE THE SLAVES** also encourages citizens to purchase certified Fair Trade or Direct Trade options whenever possible through information, education, and outreach initiatives.

# **WORK WITH GOVERNMENTS**

Governments have resources to implement comprehensive and lasting solutions on a large scale. In 2000, **FREE THE SLAVES** helped generate bipartisan support for the passage of the Trafficking Victims Protection Act (TVPA) in the United States. We have also advised a variety of governments on assisting trafficked people, prosecuting traffickers and slaveholders and preventing slavery.

- FREE THE SLAVES has testified before Congress, consulted with teh U.S. State Department and the World Bank, and helped educate Immigration and Customs Enforcement (ICE) agents charged with combating slavery in the U.S.
- FREE THE SLAVES has testified before the United Nations Educational, Scientific and Cultural ORganization (UNESCO) to discuss effects of ethnicity and race relations on modern slavery to create an open forum to share ideas and solutions across national boundaries.

# **WHO WE ARE**

## **Indika Samarawickreme**

#### **Executive Director**

Known as Indika Sam for short, Samarawickreme brings more than 20 years of international experience as a leader and strategist to the modern abolition movement. She has managed multi-million dollar programs, budgets and staff for Fortune 500 companies, and major nonprofit organizations. She takes a global perspective, having worked in program development in Africa, Asia, North America and Europe, and having grown up in Sri Lanka and living on three different continents. In addition to founding and leading her own firm, Samarawickreme provided strategic consulting and capacity building to more than 100 corporations internationally, with nine years of service focused on nonprofits. She also served on the faculty of the marketing department at the University of Pennsylvania's Wharton Business School, teaching international marketing and supply-chain management to MBA candidates. Samarawickreme has held more than 25 board memberships over a 20 year span. She is a Chartered Accountant (the U.K. equivalent of an American CPA) and holds an MBA from The Wharton School. She brings a deep, personal commitment to eradicating slavery.

#### **Kevin Bales**

#### Co-founder

Going undercover to meet slaves and slaveholders around the world, Bales exposed how modern slavery penetrates the global economy and flows into the things we buy. Named by Utne Reader magazine as a "visionary who is changing your world," and credited with one of "100 World-Changing Discoveries" by the Association of British Universities, Bales' research has sparked the creation and growth of the modern abolitionist movement. In 2000, he co-founded Free the Slaves, the American sister-organization of the U.K.'s Anti-Slavery International, the world's oldest human rights group. Free the Slaves has helped liberate thousands of slaves in India, Nepal, Haiti, Ghana and Brazil. The group works with slavery survivors to build new lives of dignity, and empowers grassroots activists to change the economic, political and cultural systems that allow slavery to persist. After reading Bales' book Ending Slavery, former president Bill Clinton told the plenary of the Clinton Global Initiative: "It tells you that it is a problem we can solve and here's how to do it." Bales holds a doctorate from the London School of Economics.



#### **Karen Stauss**

## **Director of Programs**

Stauss oversees our policy advocacy in Washington, and partnerships with community-based anti-slavery organizations in six countries. Previously, she was Managing Policy and Legal Counsel at Polaris Project, a national organization dedicated to combating human trafficking in the United States, where she managed the organization's policy and legal department. Stauss was closely involved in the drafting and advocacy for the Trafficking Victims Protection Reauthorization Act of 2008. She has worked with state policymakers on anti-trafficking legislation in dozens of states, and has recently help craft national legislation to require companies to disclose what they are doing to eliminate slavery in the businesses and products. She has represented survivors of modern slavery in their immigration-related applications and advocated for victim witnesses within the criminal justice system. Before joining Polaris Project, Stauss opened the Human Rights Watch field office in eastern Democratic Republic of the Congo. Her work there included investigating war crimes and other human rights abuses. Stauss holds a B.A. from Duke University and a J.D. from Columbia Law School.

## **Desmond M. Tutu**

Free the Slaves International Advisor Archbishop Emeritus, Cape Town, South Africa

Archbishop Desmond M. Tutu is a South African cleric and activist who rose to worldwide fame during the 1980s as an opponent of apartheid. Archbishop Tutu was elected and ordained the first black South African Anglican Archbishop of Cape Town. He has received the Nobel Peace Prize, the Albert Schweitzer Prize for Humanitarianism, the Magubela Prize for Liberty and the Ghandi Peace Prize. Archbishop Tutu presented the Douglass Award at the 2008 **FREE THE SLAVES FREEDOM AWARDS**.
